

# MEMBER CONTRACT ELLSWORTH ROD AND GUN CLUB MEMBER RENTAL AGREEMENT

This contract is for active and life members and their spouses and children. It must be signed by the member. It may be used for anniversaries, weddings, graduations, celebrations of life and other board approved special events.

Article I

The undersigned (hereinafter "Lessee") hereby leases from the Ellsworth Rod and Gun Club (hereinafter "Club") the Club building (upstairs and/or basement as specified herein) yard, and the parking area (the "Premises") located at W3930 Highway 72, Ellsworth, Wisconsin, 54011, for the event period extending from \_\_\_\_\_\_ to \_\_\_\_\_ a.m./p.m. on \_\_\_\_\_\_ to \_\_\_\_\_ a.m./p.m. on \_\_\_\_\_\_. This is the period when the facility will be opened for and used by the

Lessee.

Article II

## Article III

A. Lessee shall pay the Club a use charge for the Premises according to the following schedule:

- 1. Basement \$225
- 2. Upstairs \$225
- 3. Entire Building/Grounds\$350
- 4. Bartender (required for downstairs or entire grounds) \$100. Second bartender can be added for an additional \$100.

B. The club will charge a \$150 damage deposit, which is refundable after cleaning and inspection of the premises.

C. If Lessee cancels the Lease the damage deposit shall be returned; however, the rental fee shall be forfeited unless the Club rebooks the date for a comparable replacement event in which case the Club will refund an amount not exceeding the use charge for the rebooked event. If the Club building is determined by the Club to be unavailable because of matters beyond the Club's control (e.g., fire, weather, natural disaster) Lessee will be given a full refund of the rental fee and the Lease shall be considered cancelled.

### Article IV

Neither Lessee nor Lessee's Guests may carry onto the premises their own liquor, beer, or other alcoholic beverages. Lessee shall forfeit as a penalty twice the amount of the rental rate (in addition to the rental charge) if any such beverages are carried onto the premises by Lessee or Lessee's guests.

### Article V

If alcoholic beverages (beer or intoxicating liquor) will be a available to the guests at the event, a bartender is to be furnished by the Club. No person(s) under the age of 21 may be present in the bar area (basement) of the Club premises unless accompanied by their parent or legal guardian if the bar is open for service. Similarly, if alcoholic beverages are served in the upstairs no persons under age 21 may be present unless accompanied by their parent or legal guardian.

#### Article VI

Lessee shall be responsible for any and all damage to the Premises caused by the acts or negligence of Lessee or Lessee's guests during the event period. The deposit shall be used to pay for damages or excessive clean up expense. Lessee shall pay for any damages in excess of the deposit.

## Article VII
